



Who could have imagined the journey of the past year? We have grieved the experience of brokenness and bitter division in the midst of crisis. The walls constructed from the fear of uncertainty have revealed the insufficiency of a self-reliant culture, church and nation. This has revealed our deep need for restoration as disciples of Christ and calling to serve as agents of healing in the world. We must grow to live in the fullness of His life and in the hope in His power.

The year has afforded time to significantly invest in prayer, fasting, conversations around scripture and reading together with individuals. The experience has shaped focus and personal character that comes from fullness in relationship with Christ. We are purposed to develop Christ centered disciples that are growing in emotional health, connecting in life giving relationships and engaging in service that demonstrates the love of God. This is not a program or an event but a slow intentional process that becomes all that we are to live the kingdom of God. The personal growth in character is not an external force that imposes restriction to modify behavior. There is an emergent non-negotiable integrity reflecting the character of God that comes from a heart full of the love of Christ. Our work is growth in abiding with Him.

The 2021 theme "Beloved" seemed to be a natural progression from our 2020 theme of "Walking in the Way." Belovedness is a journey of deeply understanding our being in God's eyes. This requires the uncomfortable exposure of all the forgotten or secret places of our hearts to discover the embrace and healing of God's love. We can only experience the full work of this love in relationship with Him and others. The act of communion reminds us of this truth that we are made one, belonging to and for each other. Always becoming is the constant rest/work of abiding in Christ which matures us from self-reliance. God accomplishes this work as we learn how to surrender all that we manage, possess and control. We then can know what it is to be made one in His love.

#### Overview:

- We spent most of the year suspended from face to face activity.
- We connected digitally whenever possible. i.e. prayer, small group meetings, S.S., worship, morning reflections
- We worshipped outdoors from June to September. We were provided with warm and dry Sundays.
- Twice, we provided music as an outreach of encouragement at the Forestville Farmers Market.
- Many building projects were completed and the fellowship hall repair/remodel is ongoing. Details of these projects are listed in the Trustee report
- We began the monthly men's fellowship breakfasts in March.
- A primary investment throughout the year has been in prayer, fasting and study.
- We connected with other pastors for prayer and fasting throughout the year.
- Joshua Ellis interned during the summer leading staff book study, preaching, worship planning, teaching, and assisting with maintenance projects.
- Participated in 2 Emotionally Healthy Discipleship webinars.
- I began serving as a point person for district pastoral care.
- I fulfilled pastoral responsibilities and endeavored to live as a disciple of Jesus Christ.

The L.B.A. completed a pastoral call review with the District Superintendent recommending continuing the extended call. The next call review will take place in 2025.

#### Assistant's Report May 2020 - April 2021



#### YOUTH OVERVIEW:

• Last year we eagerly looked forward to launching a teen youth program and throughout the summer of 2020 I met with 3 different teens, although never all three at once. Meetings with one of the teens continued through the early part of the fall. As Covid made more of an impact in Chautauqua County, we missed several weeks of engagement due to abundance of precaution and awaiting test results. As winter began, the teen, who was actively involved in hockey, was unable to meet.

#### ASSISTANT'S ROLE OVERVIEW:

- Throughout the year, I met weekly with Pastor Bruce to read, study, pray and cast vision for the Church. I led Monday Morning Reflections each week, engaged in 12 Step Ministry and worked at Neighbor to Neighbor Food Pantry where I created our grocery ordering system which allowed volunteers to maintain safe distance and gave clients a choice as to which foods they wanted.
- I helped to lead our transition to online service and worked to improve the streaming experience through the integration of MediaShout7 and OBS Studio. I also continued to improve the content and functionality of our website, ForestvilleWesleyan.com. I developed Worship slide shows and Announcement Slides.
- I preached on August 16th, October 18th, November 8th, February 7th, February 17th (Ash Wednesday) and April 18th.
- In June and July, I led the Discussion and Prayer Meeting, Jesus and Justice: A Conversation about Racial Reconciliation.
- In July, I served on the Special Event Committee that created the Farmer's Market concert series that raised over \$1,000 for Forestville's new fire truck.
- In August, as a result of the Jesus and Justice conversations, we started meeting with other local pastors and began to develop the Restore Project. We met monthly for 5 months and for several months we met twice weekly for prayer and fasting. We participated in Resurgence City Backpack Day and handed out 100 backpacks and school supplies to neighborhood kids.
- In the Fall, we began work on the Fellowship Hall, I helped with the preparation for construction and developed renderings for the interior remodeling. A project that continued through the winter and is ongoing.
- In January, I contracted Covid-19. The experience was physically, emotionally and spiritually draining, but I am grateful for the love of this community that helped me through.
- In February, I had the opportunity to pray with an individual at the end of life.
- Lent was a spiritual journey through the discipline of fasting culminating in Holy Week. The discipline helped to reveal attitudes, behaviors and things that I have all too often put in the place of God. As a result of that journey, through April, I practiced relying on the fullness of God instead of relying on my coping skills.
- In March and April I led a 6 week Zoom Class focused on our theme "Belovedness" The casual format used short youtube videos and 20 minute conversations twice during the week to connect and consider what it means to be "God's Beloved".

#### GOALS:

- Recasting the vision for Youth Ministry by shifting the focus from trying to gather youth, to finding time to connect with youth and their families.
- Developing a young adult ministry with the intent of creating and equipping disciples for ministry inside and outside of the church.
- Mental Health Initiative for Neighbor to Neighbor Food Pantry. Connecting clients with providers and finding partnerships to provide funding.
- Take the next step in the Ministry Credentialing process to become a Licensed Minister.
- Continue to engage in the work of the redemption of this world through following Jesus.

I am blessed to serve, and be served by, you. The love of Christ is abundant in this community. I am looking forward to the opportunities and challenges in the year ahead.

#### Neighbor to Neighbor Food Pantry Annual Report 2021

The Pantry has had a wild year adjusting to the ever changing guidelines during the Covid pandemic.

The pantry was able to stay open but the way we met the needs of our clients was completely different. The clients were not able to come into the pantry to receive their food. We had to have them honk their horn when they arrived and we would deliver their food to them while they waited in their cars. At first we packed bags and tried to give them a variety of food then we inventoried our supplies and allowed each family to choose what they wanted to eat. We also added household items to our list like deodorant, shampoo, tooth- paste, laundry soap etc.

We realized that the pantry had to step up to the plate and offer what we could to help those that rely on the pantry. For the first time we were seeing others come because of need from lack of work and having their children being taught virtually and being home not able to access school lunches. We also had emergency deliveries that we had to make because of the Covid. We had to deliver food and drop it off at the end of driveways to those that were quarantined from the Covid.

We still take food out to our clients out of safety for our volunteers and clients.

We did have to shut down a week because we had several volunteers that came down with the virus. Almost all or all volunteers have been immunized. We are now beginning

a new chapter at the pantry, We will see where the Lord leads. We are not able to take any clothing because we have no way of showing our clients what we have.

During the last 11months we have had an average of 56 children, 99 adults and 45 seniors per month. Serving several thousand meals for those in our surrounding and immediate areas. God has been faithful with meeting the needs of His people. On our inventory sheets we have given clients places to put prayer request and the people have been utilizing this and we have been able to pray for them and those that they worry about. Continue to lift this vital ministry up in prayer as we move through this pandemic.
