Kingdom Community, Being One that others may believe Jesus

Looking back on the year, I am grateful for how God filled each day with direction and provision. His abundance always counters our thoughts of lack. We are never without hope in His presence. In *John* 15:4-5 He tells us to, "Abide in Me, and I in you...I am the vine, you are the branches; he who abides in Me and I in him, he bears much fruit, for apart from Me you can do nothing."

As a faith community everything we do should point to the center of being "in Him." There is deception in being busy, productive and accomplished without "abiding." The distraction of working toward a result rather than being in relationship with Jesus is anti-Christ. This kind of work can often bring harm to us in overwork, being anxious and disappointed in failed expectations. It can cause harm to others in our judgement, anger and resentment. However, if the work we do flows from our being with Christ, it bears the fruit of "Kingdom life." This was the message through previous the year. We experimented with different ways of speaking about it in sermons, structures of worship and styles of meeting.

"Kingdom Life," is the pursuit of abiding in a centering love for God above all else. This kind of love for God transforms how we think and what we do. The result of loving God first makes it impossible for us not to love others. This has led us, in 2023, to think about "Kingdom Community." Living in this kind of community is a commitment to each other beyond the bond of a common interest or self-concern.

"Kingdom Community" becomes an impossible picture when our love is shaped by the voice of, "Be significant...Make a name for yourself...Protect what is yours." These powerful influences around us and inside us have been at work from the beginning of humanity. They misdirect our love and create false ideas of significance that cause harm and lead us to isolation. This year we are examining God's picture of community. We want to experience His story of significance and to work toward making His name great among us. We want to care for the good news of life and the promise of God's love that makes us one. This year we want to explore being one with God and experiment with simplicity, Sabbath, service and celebration in ways that will help us to be His "Kingdom Community."

Outlook

For many years, church growth was defined mostly by the metrics of the number of attendees and the amount of giving. In spite of neither an increase in attendees nor in giving, I believe this year was a tremendous year of growth for Forestville Wesleyan Church. In a cultural moment, when churches around the country are faced with challenges of declining attendance and engagement as well as shifting cultural values and beliefs, I believe these metrics only serve to discourage us. In fact, I don't believe they ever accurately captured what it means for a church to be "growing". Instead, I have been encouraged by the tremendous spiritual growth of our small congregation.

Jesus teaches us to prioritize seeking God's Kingdom and Righteousness and to love God with all our heart, soul, and mind. He calls us to follow Him, take up our cross, and deny ourselves. In the beginning of the year, we discovered that sort of Kingdom Life looks very different from twenty-first century American life. In the second half of the year, we practiced living differently together in Kingdom Community. During the journey, I have witnessed a growing love and hunger for God's word. Together we not only survived difficult moments, but we actually helped each other grow in faith. We experienced the power of prayer. We practiced hearing God's voice. We celebrated God's goodness instead of cursing the day. We struggled with what it means to be a community of Christ followers. This type of spiritual growth is far more abstract and difficult to quantify than counting noses and nickels, but from my perspective it is the type of growth we are called to.

In the year ahead, I am eager to see the growth that God will continue to cause in and through each and every one of us. I am deeply appreciative of the opportunity to grow alongside all of you and humbled by your trust in me to be a helper in your growth.

Annual Report 2023 May 21, 2023



This past year, Neighbor to Neighbor Food Pantry was a powerful demonstration of Kingdom Community and God's provision. Every Tuesday, a small community of volunteers served the larger community around us. During the 375 hours spent in the Schoolhouse, we shared the challenges and joys of life with each other, we served, we told and retold stories, we laughed, we ate, we prayed—we lived in community. Each of the 1,000 grocery orders filled represented an opportunity to engage with members of our community. Sometimes that consisted of a quick hello and a word of encouragement, other times a longer meaningful conversation, often we had the opportunity to share a moment of prayer.

Alongside this offering of community, we fed a lot of people. This year we filled over 1,000 grocery orders representing nearly 3,000 people or 27,000 individual meals. This was an increase from 800 orders last year (which is an increase of 25%). Through the monthly Food Express we distributed additional food boxes to 1,100 households (this number is the same as last year). In total, we distributed an estimated 65,000 pounds of food and an additional 37,000 pounds of food through Food Express. This amount of food is a powerful testimony of God's provision. While poverty, unemployment, low income, chronic physical and mental health conditions and larger economic forces that impact our community continue to create food insecurity, we continue to be able to provide high quality, nutritious food choices for our clients.

God provided a small but mighty army of volunteers to distribute the combined 51 tons of food. It never ceases to amaze me that there are always enough hands to get the job done. When one person steps away, another seamlessly fills the spot. Among those who God has called to this ministry are Pastor Karen Cleveland, Pastors Bruce and Patti Ellis, Gloria Windsor, Rich Wright, Mark and Debbie Powell, Pastor Steve and Cindy Paul, Daryl Clarke, Paul Harvey, Mike Opie, Shawna Wickmark, Lois Potmesil and many other people who showed up at exactly the time they were needed most.
